G. *Terms and Conditions:*


1. The ABC is inclusive of applicable taxes.

5. Documentary requirements must be submitted on or before the deadline of submission of bids. Late bids will not be accepted.
6. ***Submit a detailed matrix of compliance of technical specifications and table of contents for documentary requirements. Without these requirements, your bid will be considered as non-compliant/disqualified.***
7. Submit your bids in a sealed envelope with (i) your complete (postal) address; & (ii) telephone, fax and email address. ***Unsealed bids will not be accepted.***
8. ***The assigned PhilGEPS Reference Number of the procurement must be indicated at the upper right portion of the envelope.***
9. If you intend to send your bids through a courier, please ensure that we shall receive it before the deadline of submission of bid ends.

11. ***Deadline of Submission of Bids:*** 11 April 2017, 5pm.
