INVITATION TO BID FOR RENTAL OF VEHICLES FOR OPAPP-Cotabato

- 1. The Office of the Presidential Adviser on the Peace Process (OPAPP) through the General Appropriations Act of FY2020, intends to apply the sum of Three Million Seven Hundred Forty Thousand Pesos (PhP3,740,000.00), being the ABC to payments under the contract for rental of twnety-eight (28) units of vehicles. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The OPAPP now invites bids for the above Procurement Project. Delivery of the Goods is required on the date that will be indicated in the Notice to Proceed. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from the address provided below and inspect the Bidding Documents at the address given below during Mondays to Wednesday from 26 October 2020 to 16 November 2020.
- A complete set of Bidding Documents may be acquired by interested Bidders 26 October 2020 to 16 November 2020, from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (PhP5,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees either in person, by facsimile, or through any electronic means.
- 6. The OPAPP will hold a Pre-Bid Conference on 3 November 2020, 1:30pm, at Kapayapaan Conference Room, 7th Floor Agustin I Bldg., F.Ortigas Jr. Road, Ortigas Center, Pasig City, and/or through video conferencing or webcasting, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before 16 november 2020, Monday, 10am. Late bids shall not be accepted.

- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. Bid opening shall be on 16 November 2020, Monday, 1:30pm, at Kapayapaan Conference Room, 7th Floor Agustin I Bldg., F.Ortigas Jr. Road, Ortigas Center, Pasig City, and/or via virtual tele-conference. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The OPAPP reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
