**INVITATION TO BID FOR MEALS/CATERING SERVICES OF OPAPP  
AND NORMALIZATION MECHANISMS OFFICIALS AND  
STAFF FOR PHASE 3 DECOMMISSIONING IN PRE-APA 5 AND  
APA 5 IN SULTAN KUDARAT, MAGUINDANAO**

1. The *Office of the Presidential Adviser on the Peace Process (OPAPP)*, through the *GAA* intends to apply the sum of *Five Million Three Hundred Thirty-One Thousand Four Hundred Pesos (PhP5,331,400.00)* being the ABC to payments under the contract for *Meals/Catering Services of OPAPP and Normalization Mechanisms Officials and Staff for Phase 3 Decommissioning in Pre-APA 5 and APA 5 in Sultan Kudarat, Maguindanao for the period of 04 October 2021 to 16 December 2021*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *OPAPP* now invites bids for the above Procurement Project. Delivery of the Goods is required by *04 October 2021 to 16 December 2021*. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from *OPAPP* and inspect the Bidding Documents at the address given below during *8:00AM to 5:00PM*.
5. A complete set of Bidding Documents may be acquired by interested Bidders on *09 September 2021 to 29 September 2021 at 10:00AM* from the given address and website(s) below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Ten Thousand Pesos (PhP10,000.00)*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *either in person, by facsimile, or through electronic means*.
6. The *OPAPP* will hold a Pre-Bid Conference on *17 September 2021, Friday at 10:00AM* at *Kapayapaan Conference Room, 7<sup>th</sup> Floor Agustin I Building., F. Ortigas Jr. Road, Ortigas*

*Center, Pasig City, and/or through video conferencing or Zoom applications (the access ID may be secured from the BAC Secretariat), which shall be open to prospective bidders.*


7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before *29 September 2021, Wednesday at 10:00AM*. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on *29 September 2021, Wednesday at 10:30AM* at the given address below and via *Zoom Applications*. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The *OPAPP* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
