- c) The price quotation must be valid for thirty (30) calendar days from the date of submission of bids.
- d) Bidder shall submit its quotation and all the required documents as well as the following documents with all its pages on or before 23 AUGUST 2022 10:00AM _____, on the place specified below:
 - 1. Mayor's/Busines Permit
 - 2. PhilGEPS Registration Number
 - 3. Omnibus Sworn Statement: Original Copy

None submission of any or all of the document will be declared ineligible to bid and hence, the bid shall be disqualified.

The above documents shall be submitted in a sealed envelope with the name of the sender, complete mailing address, email address, and telephone or mobile number. Without such details, the bid shall not be accepted.
