- c) The price quotation must be valid for thirty (30) calendar days from the date of submission of bids.
- d) Bidder shall submit its quotation and all the required documents as well as the following documents with all its pages on or before 24 AUGUST 2022 10:00 AM, on the place specified below:

1. Mayor's/Business Permit
2. PhilGEPS Registration Number
3. Omnibus Sworn Statement: *Original Copy*

None submission of any or all of the document will be declared ineligible to bid and hence, the bid shall be disqualified.

The above documents shall be submitted in a sealed envelope with the name of the sender, complete mailing address, email address, and telephone or mobile number. Without such details, the bid shall not be accepted.
